BE IT FURTHER RESOLVED, that the Chairman be authorized to execute the Employment Agreement attached hereto for and on behalf of the Board and that the Clerk attest to same; and

BE IT FURTHER RESOLVED, that all sums paid to the Deputy Fire District Administrator appear in the Fire District budget under the caption of Administration-Personnel, Salary and Wages (excluding Commissioners), and are hereby appropriated under the said caption of the budget.
