Authorizing Employment Agreement Addendum for Fire Chief in Accordance with N.J.S.A. 40A:14-81.1.

WHEREAS, the Board and Jonathan T. Yahr are now desirous to both extend and modify certain provisions of the said Employment Agreement.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners of Fire District No. 1, Township of Lakewood, County of Ocean, State of New Jersey, that it authorize the modification and extension of the aforementioned Employment Agreement in accordance with the terms and conditions as set forth in the Employment Agreement Addendum attached hereto; and

BE IT FURTHER RESOLVED, that the Chairman be authorized to execute the Employment Agreement Addendum attached hereto for and on behalf of the Board and that the Clerk attest to same; and

BE IT FURTHER RESOLVED, that all sums paid to the Fire Chief appear in the Fire District budget under the caption of Cost of Operations & Maintenance - Personnel, Salary and Wages, and are hereby appropriated under the said caption of the budget
