Authorizing Employment Agreement Addendum for Fire District Administrator in Accordance with N.J.S.A. 40A:14-81.1.

WHEREAS, the Board of Fire Commissioners of Fire District No. 1, Township of Lakewood, County of Ocean, State of New Jersey, appointed Yehuda Beer as Fire District Administrator; and

WHEREAS, the Board of Fire Commissioners of Fire District No. 1 entered into an Employment Agreement with Yehuda Beer for a term commencing November 1, 2020, and terminating December 31, 2023; and

WHEREAS, the Board and Yehuda Beer are now desirous to both extend and modify certain provisions of the said Employment Agreement.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners of Fire District No. 1, Township of Lakewood, County of Ocean, State of New Jersey, that it authorize the modification and extension of the aforementioned Employment Agreement in accordance with the terms and conditions as set forth in the Employment Agreement Addendum attached hereto; and

BE IT FURTHER RESOLVED, that the Chairman be authorized to execute the Employment Agreement Addendum attached hereto for and on behalf of the Board and that the Clerk attest to same; and

BE IT FURTHER RESOLVED, that all sums paid to the Fire District Administrator appear in the Fire District budget under the caption of Administration-Personnel, Salary and Wages (excluding Commissioners), and are hereby appropriated under the said caption of the budget.
