**RESOLUTION**

Fixing The Salary Range for The Position of Fire Prevention Specialist in Accordance with N.J.S.A. 40A:14-81.1.

WHEREAS, the Board of Fire Commissioners of Fire District No. 1, Township of Lakewood, County of Ocean, State of New Jersey, being duly organized under the Laws of the State of New Jersey, is charged to provide prevention and extinguishment of fires and regulation of fire hazards within the Township pursuant to N.J.S.A. 40A:14-81; and

WHEREAS, the Board of Fire Commissioners of Fire District No. 1, Township of Lakewood, County of Ocean, State of New Jersey, finds a need for a Fire Prevention Specialist (Job Specification Code 06356) within the district in order to carry out the mandated charges as set forth above; and

WHEREAS, on April 11th, 2022, the Board of Fire Commissioners adopted Resolution No. 2022-04-11-02 establishing the paid position of Fire Prevention Specialist (Job Specification Code 06356) in accordance with N.J.S.A. 40A:14-81.1; and

WHEREAS, the Board intends to fix a salary range for the above mentioned position.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners of Fire District No. 1, Township of Lakewood, County of Ocean, State of New Jersey, that the minimum and maximum annual salary range for the position of Fire Prevention Specialist (CSC Job Specification Code 06356) shall be and is hereby fixed as follows:

Minimum: \$45,000.00      Maximum: \$75,000.00

BE IT FURTHER RESOLVED, all other terms and conditions of employment relative to said position shall be established by the Board of Fire Commissioners of Fire District No. 1.
