PLEASE TAKE NOTICE that sealed bids will be received by the Board of Fire Commissioners of Fire District No. 3, Township of Wall, for preventive maintenance/repair to fire apparatus and vehicles on Thursday, June 16, 2022, at 10:00 a.m. prevailing time at the Wall Fire District Administrative Office, 1612 Route 71, Wall, New Jersey, at which time they will be opened and read by the Board Clerk or designated representative.

Bids must be enclosed in a sealed envelope marked "Maintenance and Repair" on the outside addressed to the Board of Fire Commissioners of Fire District No. 3, Township of Wall. The bid must be delivered to the Wall Fire District Administrative Office, 1612 Route 71, at 10:00 a.m. on June 16, 2022. If mailed, all bids must be mailed by Certified Mail to the Board of Fire Commissioners of Fire District No. 3, Township of Wall, Attn: Purchasing Agent, 1612 Route 71, Wall, New Jersey 07719, and received on or before the above set forth time and date.

No bid will be considered unless in writing on the form furnished.

Bids may not be faxed, transmitted over the telephone or emailed. The Board of Fire Commissioners of Fire District No. 3, Township of Wall, assumes no responsibility for delays in any form of carrier, mail or delivery service causing the bid to be received untimely.

Bidders must submit with the bid an "Ownership Disclosure Form" and a "Non-Collision Affidavit" on the forms included in the bid package.

Bidders must submit proof with the bid of registration with the New Jersey Department of Treasury, Division of Revenue, by submitting a copy of bidder's Business Registration Certificate.

Pursuant to N.J.S.A. 10:5-31, bidders are required to comply with the requirements of P.L. 1975, c.127, N.J.A.C. 17:27.

The Board of Fire Commissioners of Fire District No. 3, Township of Wall, reserves the right to reject any or all bids not deemed to be in the best interest of the Fire District.

It is the purpose of the Notice to Bidders to summarize some of the provisions of the bid documents. Prospective bidders are cautioned not to rely solely on this Notice but to read the bid documents in their entirety.
